- I. Invoices for fall term will be mailed out mid-summer 2010. It is understood that the total fall tuition must be paid **no later than August 23, 2010**. A parent meeting will be held in conjunction with the CSA board meeting on September 13. The fall term begins the same day, September 13, 2010. A minimum down payment of \$20.00 per family is due at time of registration. Subsequent winter/spring tuition fees will be billed at least six (6) weeks prior to the start of each term with full payment due one-month in advance of the start of the term. Checks/money orders must be payable to the Cadillac String Association or CSA. The fee schedule is listed below.
- II. **It is understood that no instruction will be offered until tuition has been paid in full. All fees collected are non-refundable after the start of the term.**
- III. The teacher must be notified 24-hours in advance if the student is to be absent from a lesson. If a student cancels a lesson, **makeup lessons are at the discretion of the teacher** and then, only in cases of illness or extreme emergency. Private lessons cancelled or missed by the teacher **will be made up**. No group classes missed by the student can be made up.
- IV. Snow days for school will often require cancellation of private and group lessons. Teachers are not required to make up snow days, but they often attempt to reschedule. However, if more than one snow day occurs during your child's private lesson that is not rescheduled, the cost of the second (or more) lesson cancelled due to snow will be reimbursed by the CSA.
- V. Because parents/guardians play a critical role in the child's education, the parent/guardian should encourage and support the child's music study, supervise home practice, and see that the student arrives on time for lessons, is properly prepared, and has their music and instrument.

\$32.00 per 60-minute lesson (\$352.00 per 11-week term)

\$ Group Lesson, Chamber Ensemble or reading orchestra fee \$90.00 per year, billed \$30.00 per term

**Fundraising is the responsibility of all String Association families.** Fundraising is critical to our status as a grant recipient, and it helps provide expanded services to students at affordable cost.

Length of private lessons will be determined by the teacher. Standard private lessons are 30-minutes per week. Participation in group lessons (or chamber ensemble, as appropriate) is expected of all students. Teacher recommendation is necessary for participation in either the reading or intermediate orchestras or fiddling class.
